Learn About the Atlantic Immigrant Career Loan Fund

Immigrants looking to continue or advance their careers in Atlantic Canada are invited to attend a free online information session about the Atlantic Immigrant Career Loan Fund (AICLF) on

Monday, July 13, from 2:00–3:00 p.m. ADT.

The webinar will provide an overview of the AICLF, an initiative led by ISANS that helps eligible permanent residents and Canadian citizens access affordable financing for training, licensing, and certification needed to work in their chosen professions or related fields.

Participants will learn:

- Who is eligible for the program
- What training and certification costs may be covered
- The types of education and professional programs that qualify
- How the program is funded and delivered across Atlantic Canada
- Why the AICLF may be a valuable alternative to private financing

There will also be an opportunity to ask questions during and after the presentation.

Advocacy in Action

Chamber Submits Comments on Proposed 15-Mile Project

The Pictou County Chamber of Commerce recently submitted comments during the planning phase of St Barbara's proposed 15-Mile Processing Hub Project. As an organization that supports a strong, sustainable, and resilient business community, the Chamber recognizes the potential economic opportunities that major projects can bring, including local employment, business growth, procurement opportunities, and investment in rural Nova Scotia.

At the same time, we believe economic development and community responsibility must go hand in hand. Our submission emphasizes the importance of a thorough, transparent, and evidence-based review process that carefully considers environmental stewardship, meaningful community engagement, Indigenous consultation, and long-term accountability.

While the Chamber did not provide technical comments on the project's environmental or regulatory aspects, we encouraged decision-makers to ensure that community concerns are fully considered and that any future decisions reflect both the potential benefits and the legitimate questions raised by residents and stakeholders.
